The program is completely online and can be completed at your convenience. The pharmacology course has an optional zoom meeting held weekly. Students are encouraged to attend these weekly sessions to keep up with their progress. Once registered, we'll send you getting started information to start your online courses by the start date.

There are three components to our program:

Application assistance (assistance with the application process)

Pharmacology online (Google classroom)

Cna To LVN online course (which explains the process of challenging the board)

Currently the program is for those who want licensing in California. A few other states will allow transfer of this type of license. Those states we can guarantee are FLORIDA, COLORADO, SOUTH CAROLINA AND ARIZONA. If from one of these states, you must challenge in California then transfer your license. We assist through the whole process for no additional fee.

The program is \$1099 with a \$150 registration fee. A deposit of \$150 includes registration fee required for admission to the program. If paid

in full you save \$100 plus free registration. We do accept payment plans. We require just a minimum of \$50 every two weeks, transcripts are not available until all payments are complete.

Cna to LVN Lpn equivalency assistance program

Program Curriculum

How this works

Welcome to the Cna to Lvn equivalency assistance program. This program is designed to help CNA's with the appropriate experience to challenge the board in California. We will cover how the program works here.

Students are required to register for the requested term they are interested in. Registration is only refundable if you are determined not to be a qualified candidate. Refunds will only be provided to students prior to the start of the session. You will ask to schedule an phone or in person interview near the start of the session on which we will review the requirements and evaluate your experience. Students must complete the required registration forms prior to this interview.

Prior to admission to the CNA to LVN/LPN equivalency program, students must schedule an appointment for interview with the instructor.

During this interview it will be determined if you are a candidate for equivalency/method three. You will be advised on the options you have and a program outline will be designed. Students will receive detailed outline instructions on how to complete the courses. It is suggested to follow the instructor's recommendations.

To help students with their progress, we develop a "Cna to LVN checklist" comprised of 10 steps for students to follow. We suggest following the checklist in order unless otherwise instructed.

After the interview process and the student is an appropriate candidate for equivalency student would be allowed to enroll in the program. Most students are allowed to start prior to the official enrollment date. Depending on the amount of students in the cohort you might be asked us to wait until the actual start date.

The CNA to LVN program required courses are the Cna to Lvn how to challenge the board course and the pharmacology online course. These are the only two courses included with the program. The third element of the program is application assistance in which we assist you with the process of completing your application with the board of nursing.

The board of Vocational Nurses and Psychiatric technicians is the governing board over LVN licenses in California. The board is the issuer of Lvn licenses and Cna Resource Center is here to assist you with the process of challenging the board for Lvn licensure. Students must understand that Cna Resource Center does not issue Lvn licenses.

Students enrolling in the complete total assistance program, will start with the "CNA to LVN: how to challenge the board online" course after completing the first step "Interview with Instructor" This course is designed to show you the actual steps that we will take to help you

challenge the board for nursing licensure. It is strongly recommended to complete this course prior to studying pharmacology or completing an application. The CNA to LVN online course will walk you through all the stuff that we will help you do. It's a step-by-step guide on the steps of challenging the board and is it strongly suggested. After completion of the online course, the student will have a better understanding of the process. At that time it is a advised that the student complete an application for licensure with the board of nursing.

Again, Each student will receive a Cna to nurse checklist included in the registration forms. This checklist will also be included in the Cna to Lvn course. This checklist is designed to help you keep track of you progress. Mark off each step as it is completed. It is suggested to complete the items in order on the checklist unless instructed to do otherwise. Some students are advise to complete an application immediately upon enrollment.

After completing the Cna to Lvn course, we suggest starting the pharmacology course. Most students participating in the CNA to LVN/LPN equivalency program will be allowed to access the pharmacology course immediately upon enrollment.

The pharmacology course is a college course consisting of three units and 54 hours of theory. This pharmacology course is required by the board of Vocational nursing and psychiatric technicians in California for method three applicants for vocational nursing licensure (challenging the board). Students must spend a minimum of 54 hours on the course to receive credit. Students must also pass all exams by a minimum of 75% for a passing score.

The pharmacology course will also be online. Both the pharmacology course and Cna the LVN course will be accessible on our Google classroom platform. Students should make sure they have access to Google services preferably by having a Google Gmail account. The pharmacology course will have weekly zoom sessions that are optional for the students. During these weekly zoom sessions soon can ask questions in regards to the pharmacology course and also in regards to the process of challenging the board. Do the zoom sessions will be every week for four weeks.

After the completion of the pharmacology course students can contact the instructor for application assistance up to one year from the date of enrollment.

Prerequisites for the pharmacology course are just basic medical knowledge. Students are advised to complete the pharmacology course in order starting with module one. Books required to complete the pharmacology course are listed in the course. Items required include a drug book dated at least 2015 and a medical dictionary. Optional books include pharmacology made incredibly easy, fourth edition.

For our courses we use an interactive platform on google classroom. The student is required to establish an gmail account to access the course. Establishing an account is free. You will receive an email with set up instructions for the course once registration and interviews are complete or at the start of your session (whichever comes first).

The quizzes and exams are held weekly. The 54 hour pharmacology course is set up to be completed in one month however students will have up to six months to complete the course.

. You will receive links via email or text to access the classroom

One students have completed all payments and completed all requirements regarding passing the pharmacology course, the student will be issued a certificate of completion. Upon completion of both of those requirements certified transmission will be sent to the board of vocational nursing on behalf of the student at no additional charge. One Transcript will be sent to the students at no additional charge. All additional transcripts will acquire a \$10 fee for certified transcript and a five dollar fee for any copies.

Students are allowed to make their own payment arrangement. Cna Resource center requires a minimum of \$50 every two weeks. Late payments are OK in some instances. However payments over 30 days late will incur a \$50 reinstatement fee. Students can be dropped from the

course if payment is not received if payment is more than 30 days late. Once a student is in enrolled there are no refunds given for class payments. If students are dropped from the course or decides to not complete the program at any time there are no refunds given and students must be re-enrolled and complete a new registration to start again..

Upon enrollment into either our pharmacology, CNA to LVN online course or CNA to LVNLPN equivalency Assistance program students are required to maintain all payment arrangements and obligations. No transcripts will be made available to any students with an outstanding balance. We are not responsible for any denial in regards to the board that does not involve our pharmacology course. Students are required to have the experience necessary to challenge the board. Evaluation of experiences is at the Board's discretion and not ours.

It is advised that students complete an online application with the board of vocational nurses and psychiatric technicians as soon as possible. Some students decide to complete the application after completing the pharmacology course however Please be advised that Board processing times vary between 6-8 months for online applications, and up to 12 months for paper application. So get your application in asap.

How does the Cna to LVN program work?

Our cna to LVN program is designed to assist cnas with at least 5 years exp with challenging the board of nursing in California for LVN licensure.our program is not a vocational program and the required experience is needed. We can send you the program guide that explain how it work via email if you like, after you can then speak with the instructor if you have more questions.

I want to signup for the program, how do I do it?

Please visit our site cprforall.eventbrite.com and register for the class today for only \$150. Once you register, you will receive a email from the instructor with instructions on how to complete registration. We can also send you registration forms via email if you like.

How much is the program?

The Cna to Lvn Equivalency Program is currently \$1099. Our Cna online program is \$699. Pharmacology only \$499. All programs require a \$150 registration fee, payment arrangements available after registration. Early registration get a \$100 discount if registering at least 2 weeks in advance.

I'm not in California, can I still enroll in the Cna to Lvn Lpn Program ?

Yes if you want to be licensed in California. Some states will allow your to transfer your license. States we can assist are Arizona, Florida, Colorado at this time

When is the next class?

The next Cna to Lvn Lpn session is 6/1/22, 8/1/22, 12/1/22. All sessions are open for enrollment. Pharmacology course is available online monthly for those students who don't need application assistance.

I need ceus for my Cna license?

We are available 5 days a week for ceus. Our regular rates are \$50 for 12 units.

I don't have maternity or pediatrics experience, Can I still challenge the board?

The 6 week maternity and pediatric requirement is a requirement of the board to challenge the LVN exam. Unfortunately if you do not have this experience you are not eligible to challenge.
